#### **Environmental Health Division**

Chris reported that local food facilities were invited to attend a meeting for an FDA presentation on the upcoming changes to the food policy. There will be a Food Safety Advisory Committee that will meet monthly to go over issues and what's changing in the requirements. The program review for food, water and sewage went well and should receive documentation of the review by June. The state is now trying to do the reviews virtually due to lack of funding and personnel available to travel.

The Department of Ag in Galesburg and Peoria are closing. Galesburg is where we send our animals to be rabies tested. Springfield state lab is unable to do the testing so the nearest place will be Champaign/Urbana. We will be having our SNS exercise on June 29<sup>th</sup> at WIU. We are working on the details of the scenario and meeting once a month. The website went live today.
