# Community Health Division

Kerri Allen, Community Health Director

Kerri reported the nurses have been busy with the mumps cases. There have been 47 cases and investigated 66. The onset date for the last case was May 26 and as of July 15, that marked the end of our 50 day outbreak

status. However, WIU will be back in session as of August 20<sup>th</sup> and we are working with Beu on protocols of what to do if it appears again this school year. Staff has been attending meetings and various trainings. We have hired Anne Chatterton- Abbott to fill the position of Health Educator/PIO. She plans on going to nursing school. We have not hired a nurse yet. We have interviewed a few applicants. Two have turned down the position due to the pay. Kerri and her staff have been moving offices to different rooms and have moved the freezers up front. After adjusting the water bottles in the refrigerator, it seems to holding temperature properly and we will not need to purchase a new unit. Kerri is starting to plan the Fun Run.

## Administrator's Report

Lynnette Cale, Administrator

Lynnette reported that grants are slowly coming in for FY19. Tobacco grant is due next week and the PHEP grant was due today. Local health protection grant is encompassing 6 grants this year. The dental sealant grant is done and we are waiting on the tanning and body art grant. The WIC grant will decrease this year but the tobacco grant will be the same amount. Lynnette found out that they plan to begin demolition of the County Market building on Monday. Next board meeting we will be discussing FY19 budget.
