Environmental Health Division

Chris Adams, Environmental Health Director

Lynnette reported for Chris that Environmental Health has been running tests on mosquitoes for West Nile Virus and submitted four birds. All tests have come back negative for the virus.

Community Health Division

Kerri Allen, Community Health Director

Kerri reported that last week's WIU drive through clinic went well. People were thankful for what they did. We did 473 flu shots. Schuyler County will do their State Flu Clinic on October 15 at the prison in Rushville. More people are wanting flu shots due to Covid. Kerri had a zoom conference with our vaccine representatives from Sanofi and Merck about not receiving flu vaccine. Kerri stated that she doubled the amount of vaccine that we ordered this year. We plan on having several more flu clinics. We have one scheduled for BPC Schools, St. Paul and Schuyler has a few scheduled. We will begin doing bloodwork again next week. They will all be done by appointment and we plan to keep the doors locked until after the election. We have hired seven contact tracers and 4 PRN nurses for immunization clinics. We are still looking to hire a PIO. This pandemic has been a mental drain on the employees. McDonough County's current rolling positivity rate is 9.6 and Schuyler County's is 7.10. Country View is currently in outbreak status.

COVID-19 UPDATES

Lynnette discussed with the board what warning and mitigation levels are. Warning is done by county and mitigation is done by region. It's been a busy month. Current data shows that 33 patients were admitted at Blessing Hospital with Covid. On Columbus Day, the caseload was heavy. Half of the MCHD staff came in and worked the cases. There is an outbreak at Country View. On October 23rd, Bushnell Prairie City schools closed due to Covid. Catch-A-Star daycare closed due to Covid. We have been providing PPE to long term care facilities. The state flu shot clinic was a good dry run for when we are ready to do a Covid vaccination clinic.

Ben Thompson reported that we will be receiving Abbott Bionex tests from IDPH. McDonough is expected to receive 480 tests and Schuyler is to receive 120 tests. Staff will be trained on how to use the tests. We received a red notification from IDPH. IDPH plans to do Covid testing next week at WIU Q lot, SRC Outreach Center and at Bushnell Prairie City Jr. /Sr. High School. All tests are being provided free by the state. People can expect their results back in 4 to 7 days.
