## **CONSTRUCTION PROJECT**

#### MULTI-PURPOSE ROOM BIDS AND APPROVAL

Benton and Associates put out a bid for an approximate cost of \$45,000 for our construction project. They received two bids, one from Trotter Construction for \$33,111 and one from Lavediere Construction for \$51,778. There was a difference of \$18,667 between the two bids. Since there was no itemization done on the bids, Doug from Benton and Associates couldn't tell the board why there was such a difference. Trotter said they weren't very busy right now and would be able to start immediately whereas Lavediere is busy and wasn't sure when they would be able to start the project. Benton and Associates had noted on the bid that it had to be completed by March 25<sup>th</sup>.
